The Clinic was founded in 1981 by Most Rev. Thomas John Paprocki and Edward Grossman, in response to the economic devastation of the South Chicago community. Reduction of steel mill operations had forced a 35% unemployment rate, with a ripple effect that encompassed nearly every business in the area. What had been a self-sufficient, blue collar community was suddenly in crisis. The Clinic immediately stepped into the breach by filling the legal needs of many area residents.

Today, the Clinic is one of the pillars upon which the legal services community of Chicago stands. It is the principal provider of legal services for most of the South and West sides of the City. Through its neighborhood offices and advice desks, 24,000 clients are being served this year. We have served over 400,000 people, enhancing their lives and those of their families. This work is made possible through your generosity and we thank you for sustaining us these many years.
