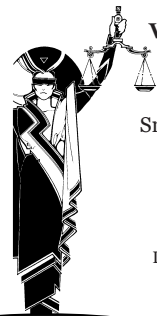

Equal access to justice is a fundamental value of our American democracy. The notion of equality in the eyes of the law is one that all Americans can embrace regardless of economic, social or cultural backgrounds.

For 36 years, the mission of the Chicago Legal Clinic, Inc., has been to promote equal access to justice by identifying legal needs and providing community based quality legal services and education to the underserved and the disadvantaged in the Chicago area.

The Clinic was founded in 1981 by Most Rev. Thomas John Paprocki and Edward Grossman in response to the economic devastation of the South Chicago community caused by the reduction of local steel mill operations. Over the next three and a half decades, the Clinic grew into one of the pillars upon which the legal services community of Chicago stands. Today, the Chicago Legal Clinic is the principal provider of legal services for most of the South and West sides of the City.

On February 27, 2017, after more than three decades of exceptionally strong and dedicated leadership, Edward Grossman stepped down as the Executive Director of the Chicago Legal Clinic. The Clinic's new Executive Director, Adam M. Salzman, is dedicated to maintaining the Clinic's position as the premier provider of legal services to the poorest, most vulnerable populations in Chicagoland. Through its neighborhood offices and advice desks, 23,000 clients will be served this year. Since its inception, the Clinic has served over 435,000 people, enhancing their lives and those of their families. Without your ongoing support and generosity, this work would not be possible. We are profoundly grateful for all you have done to sustain the Chicago Legal Clinic these many years.
